During this time he developed and oversaw major "telenovela" productions as Executive Producer, including "Aquamarine," "Maria Celina," "The Women of my Life," "Enamorada," "La Revancha," "Secreto de Amor," "Gata Salvaje," "Rebecca" and "Angel Rebelde." In 2004, **Mr. Schwarz** associated with Televisa, and produced the international acclaimed soapoperas "Inocente de Ti," "Love is Priceless," "The Two Sides of Ana" and "Under the Reins of Love." Fono Video provided production services for major television networks such as Telemundo, Venevision International and RCN for over 35 years.

From 1977 and 1996, **Schwarz** produced - Live in his native Venezuela - countless sporting, cultural, and musical events. During two decades he developed and produced more than fifty television programs in which he's credited for including "Mansion de Luxe," "Cristal," "Topacio," "Cronica Policial," "Kaina," "Pecado de Amor" and "Bienvenidos" among others.

Schwarz holds a Bachelor of Arts in Broadcast Journalism from the Industrial Technical School Salesians in Caracas, Venezuela.
